- 1. Give an example of an algorithm whose average case running time is different from its worst case running time. Explain your answer in clear terms.
- 2. Given the decimal value -16.75, use IEEE 32-bit single-precision standard system to represent this value.
- 3. We want to create a (small) instruction set for a computer that has 4 general purpose registers named R1, R2, R3 and R4, and one dedicated register named RESULT. The individual instructions that the computer needs are as follows:

1. increment a register (add 1 to the contents of the register, stores the new value in register RESULT).

2. add any two general purpose registers, put the sum in register RESULT.

3. multiply any two general purpose registers, put the product in register RESULT.

4. copy the value in register RESULT to any one of the 4 general purpose registers.

Develop a 6-bit binary machine code that encodes these instructions (each instruction must be 6 bits). Provide the details of your encoding (describe your machine code here)

4. A computer employs RAM chips of size 256 x 8 and ROM chips of size 1024 x 8. The computer system needs 2K words (word size 16 bits) of RAM, 4K bytes of ROM, and four interface units each with four registers. The two highest-order bits of the address bus

are assigned 00 for RAM, 01 for ROM and 10 for interface units. Prepare a memory/component address map for addressing these components.

5. Let L be a language recognizable by a finite automaton. Determine the type of language realized by REVERSE(L)? Please justify your answer.

- 9. Give the structure function of 3 out of 4 system, with subsystem structure functions as f1, f2, f3 and f4.
- 10. Suppose relation R(A,B,C,D,E) has the functional dependencies
