Evidence of a previous conviction for robbery having been given against the prisoner, the magistrate refused to deal summarily with the offence, but referred it to the Assizes. Jacques who had shown signs of intense emotion during the proceedings, fainted away at the conclusion and was carried out of court."

- Q: The mixture of soda and water is boiled before putting the dirty cotton clothes into it. Then soap is applied and the clothes are rubbed hard till the dirt is pushed of. After that, the clothes are rinsed with water.
