Also they are expected to take up work related to the area of their optional paper.

c) Identify the thrust areas, rules and regulations of agencies and their services available, in response to these needs/problems.

d) identification and use of appropriate social work methods to deal with problems identified.

The fieldwork during third year shall carry a maximum of 60marks(30+30).
